66 participants representing National, Regional and International Partners in the leather sector from 10ALLPI member state countries, namely; Burundi, Eritrea, Ethiopia, Kenya, Malawi, Rwanda, Sudan, Uganda, Zambia and Zimbabwe.

The Executive Director of ALLPI in his opening remark appreciated the Government of Uganda in general, and Ministry of trade, industry and cooperatives in particular for accepting to host the 15th Regional Leather Sector Core Team and Stakeholders Consultative Forum.

The Guest of Honour Minister of Trade, Industry and Cooperatives, Uganda- Hon.

Frederick Ngobi, thanked the executive director ALLPI and sponsors of the event for bringing the forum to Uganda, explained that Uganda government recognizes the importance of the leather sector due to its enormous potential in employment and wealth creation, reiterated the government support in implementation of the leather value chain strategy, enumerated the activities of the government on the leather sector, appreciated the sharing of experiences on key issues geared at accelerating development of the leather sector, and implored all ALLPI member states to make effort to ensure that standards for consumables like leather are in place and are harmonized within the region and global scale. Hon. Minister also informed the forum participants that development of guidelines for eco-certification is underway to mitigate greenhouse gases emission from industrial sector and emphasized the importance of exploitation of agri-business sector has opportunity for better returns and create more jobs.

During the three days' workshop, various presentations were made. Some of the presentations include but not limited to Report of the 14th Regional Leather Sector Core Team (RLSCT) Meeting and Matters arising, Report of the 8th SMEs Technical Committee Meeting and Matters Arising, Member States Leather Sector Profile presentations, ALLPI 2021/2022 Key performance and program of action plan presentation, Collaborative Research Results presentation, Progress of RECAMP Program Activities, BADEA and RDS Project activities Curriculum Harmonization process, ALLPI digital platforms (E-Commerce, E-Learning, Online Traceability System), and focus group discussions presentations by SMEs, Tannery

and Chemicals, Academia & Member States.

Out of the focus group discussions, the following issues have clearly come out:

- » Segment operation among various players to reduce the burden of huge finance for investment;
- » Vibrant leather associations to negotiate with government for tenders to keep them afloat and inject the much-needed cash;
- » Member institutions to strengthen interaction with SME and industry and carry out research geared to solving their problems;
- » Review the national leather value addition strategies for all Member States;
- » Improve the quality of design through Satellite design studios and regional design studio;
- » Implementation of an effluent waste treatment system by inviting the development partners and UN environment agencies;
- » Engage stakeholders through the Triple Helix approach;
- » Profiling the MSMES in the different member countries.
- » At the end of the workshop, the following recommendations were made by participants
- » to be overseen by ALLPI:
- » Member states to allow the same SMEs officials to attend regional ALLPI meetings so that it is easier for them to implement resolutions made;
- » Regarding the ban of importation of second-hand footwear, the following steps should be considered first;
- » Statistics on the footwear demand in the region be mapped Phased
- » implementation of the ban be formulated as local capacity is increased;
- » be put in place to minimize the quantities reaching member states;
- » Government to support the leather industry in purchasing locally made products
- » which will in turn create capacity to manufacture

more products for the domestic markets.

- » Quota system be put in place to support the ban
- » Come up with mechanisms to increase production of leather consumer goods
- » (footwear and leather goods) to increase demand for finished leather to ensure tanneries survive.
- » Governments to take the initiative to provide infrastructure and financial support
- » to leather value chain activities to enable the tanneries to survive;
- » Funding models to be explored to support SMEs and leather industries and be specific to the sector such as SMEs development advocacy banks;
- » Invite financial institutions to the forum so that they understand the leather sector
- » and formulate financing models that fit it;
- » Government to come up with funding mechanisms for industry and SMEs with

affordable interest rate;

Issues of quality and quantity of leather be addressed to be able to supply local requirement;

Encourage benchmarking activities amongst member states and sharing of the good success stories; On the third day of the forum, the participants visited Kawumu Tannery to appreciate the Ugandan government commitment towards the development of the LeatherSector.Kawumu Tannery which is located in Luweero district is a presidential initiative aimed at enhancing value addition in Leather sector. It is a multi- million dollar investment comprising of a modern Tannery and an Influent treatment plant. The tannery is providing affordable finished leather to the SMEs in Uganda.

Under the same Presidential initiative, a shoe factory will also be established as partof value addition for finished leather from the tannery.

The tannery is run by Engineer Roy Kathavrayan, with 40 years experience in theleather sector.

The occasion was graced by the State house Comptroller, Mrs Jane Barekye.

ALLPI delegates Conclude a working Mission to the Republic of Sudan Leather Sector

Africa Leather & Leather Products Institute (ALLPI) conducted a successful mission to the Republic of Sudan 23 – 28 October 2022.

The aim of the mission was to discuss on how to further strengthen the collaborations between the leather value chain stakeholders of Sudan and the ALLPI so that to enhance the process of transformation of the leather sector in Sudan. The mission was planned and implemented in collaboration with the Sudan COMESA coordinating unit of the Ministry of Trade and Supplies.

The ALLPI delegates in its four days mission conducted fruitful meetings with different stakeholders in the Sudanese Leather Value Chain:

The first meeting was conducted between the representatives of the Ministry of Trade & Supplies and the ALLPI in which delegates the discussion concentrated on bilateral issues concerning ALLPI's intervention in the value chain and Sudan's assessed contribution were thoroughly discussed. In the meeting the Ministry expressed its satisfaction with collaborative activities and affirmed Sudan's commitment to its membership and confirmed its commitment to fulfil its obligations.

Following the meeting with the ministry the delegates next stopover was Sudan University of Science & Technology (SUST). In this meeting the parties reviewed the ongoing collaborations between the SUST and the ALLPI. The Vice Chancellor of Sudan University Professor Eisa Bashier M. Tayeb commended the collaborations between SUST and ALLPI and thanked the institute for its continuous support to the university. The head of the ALLPI delegates Mr. Ghebregziabher Ghebremedhin in his turn joined the V/C in praising the partnership between the Sudan University and the ALLPI and confirmed ALLPI's commitment to the partnership in the future. At the end of the meeting the V/C awarded an emblem of the University to the delegates as an expression of his appreciation to activities of the institute.

The Delegates also further conducted meetings with the representatives of the Ministry of Industry, the National Leather Technology Consultancy (NLTC), the ministry of manpower and human welfare, Sudanese Chambers of Industries Association, the Sudanese Standard and Metrology Organization (SSMO) and Ministry of Animal resources.

H. E. Minister Marie Chantal Nijembre launched the Kamenge Leather SMEs Incubation Center/ Satellite Design Studio in Bujumbura, Burundi

A Small and Medium Enterprises service providing center established at Kamenge Artisans Production Center was launched by H.E. Madam Marie Chantal Nijembre, Minister of Commerce, Transport, Industry and Tourism on the 4th of November 2022. In the Launching ceremony, ALLPI delegation composed of Mr. Ghebregziabher Ghebremedhin programmes Coordinator and Professor Mekonnen Hailemariam Advisor to the Executive Director attended the launching ceremony following the invitation of the honorable Minister Madam Marie Chantal Nijembre.

H.E. in her speech hailed the establishment of the center which is expected to contribute to the transformation process of the leather sector in Burundi. She reiterated government's commitment to support the leather sector in general and in making the incubation center workable in particular. She gave her guidance on how the incubation center will be managed. Workshop to Enhance market access and local sourcing for SME's conducted in MTAC, Kampala Uganda

Africa Leather and Leather Products Institute(ALLPI) with the Government of Uganda Ministry of Trade, Industry and cooperatives conducted a one day workshop to selected SME's from Uganda on 5th December 2022 at MTAC Hall Kampala, Uganda.

The overall objective of the program is to give information regarding the supplier of input and main institutional buyers along the leather value chain to in hence the marketing activities of SME's domestically as well as globally.

The one day workshop was conducted based on the field visit arranged with different input suppliers along the LVC and institutional buyers during 28th November -4th December 2022 in Kampala. The detail activities were:

- » Collect data on finished leather and accessories importers and institutional buyers of finished leather products,
- » Organize meeting between micro enterprises and importers of raw materials and
- » Train SME's on how to approach potential institutional buyers

During the workshop the opening remark was conducted by ALLPI's program Coordinator Mr. Ghebregziabher Ghebremedhin and he addressed the importance of this session to enhance marketing Linkages of SME's. He also addressed ALLPI's readiness to continue supporting Africa leather sector in general and Uganda in particular so that the sector players get the required share in Leather sector trade dynamics globally.

During the workshop the presentation was delivered by ALLPI's Investment, Trade and Marketing expert Mrs. Birkinesh Gonfa based on the field work conducted to identify potential suppliers of input and potential buyers. Also The Africa business directory website developed by ALLPI to support Leather business actors to Search information regarding input output linkages, to register themselves and promote their products and updated their company information based on the updated history of the company was presented.

This workshop was delivered for Leather actors TOT in Footwear and leather good design, Craftsmanship, export readiness conducted from

28th November- 4th December 2022.

Input suppliers challenges and buyers requirements discussion was also conducted during the workshop to plan the support activity with the ministry of Trade, Industry and Cooperatives of Uganda.

At the conclusion session ALLPI program's coordinator expressed his happiness by discussion and feedback from the participants and wished a successful activities in their business.

Training of Trainers in Footwear and leather good Design, Craftsmanship, Export Readiness conducted at the MTAC, Kampala Uganda



Africa Leather and Leather Products Institute (ALLPI) carried out a mission in Kampala, Uganda. This is in efforts to boost its member states Leather sector SMEs Productivity and Competitiveness.

This intervention was made possible through the grant funding Technical support provided by the Arab Bank for Economic Development in Africa (BADEA).

The support comprises provision of “basic equipment for footwear production” and “capacity building Training in Footwear and leather good Design, Craftsmanship, Export Readiness, Transformative Entrepreneurship, Costing and Record Keeping”

Earlier in 2022, ALLPI completed installation of equipment at MTAC in Kampala. The installation of the equipment was followed with the capacity building training which commenced on the 28th November, 2022 at MTAC and ended on the 4th Dec, 2022.

The objective of the training was to boost productivity and competitiveness of the SMEs to attain growth through learning the fundamental dynamics and principles of, Leather Footwear and Goods, Design, Product Development, Manufacturing, Craftsmanship, Exports Readiness, Transformative Entrepreneurship, Record Keeping, ,and Costing and pricing. This is with the purpose of shifting the mindset to embrace changes and promote replication through knowledge sharing.

Another aspect of this intervention was to enhance

SMEs technical capacity and economies of scale to supply both Public and Private Sector institutional buyers by carrying out the assimilation of the Cluster, Incubation center and Design Studio concept in the SMEs Business Strategy, identification of the Public and Private Institutional buyers, identification of the products demanded by the Public and Private Institutional buyers (fashion or non- fashion orientation products, identification of SMEs footwear products for defects against the institutional buyers technical and quality specifications.

The Training was conducted by an extenal Consultant/Trainer Mr. Feraw

Kabede from Ethiopia. The ALLPI team comprising of the Regional Design Studio Manager, Mr Preston Viswamo, and the Quality Assurance, Innovation and R&D Expert- Dr. Abdel Rahim Mohamed Ahmed facilitated the training activity.

The training was graced by Mr. Cleapas Ndorere-Assistant Commissioner, Ministry of Trade, Industry and Cooperative- Processing and marketing department. In his speech, he welcomed the ALLPI Experts Team that had come to Uganda to conduct the training.

He explained to the participants that the training activity was a good opportunity for them to build their skills as future instructors in the cluster. He encouraged the participants to pay attention to the

The support comprised the provision of “basic equipment for footwear production” and “capacity building Training in Footwear and leather good Design, Craftsmanship, Export Readiness, Transformative Entrepreneurship, Costing and Record Keeping”

Earlier in 2022, ALLPI completed installation of equipment at the Cooperative College in Lusaka. The installation of the equipment was followed with the capacity building training which commenced on the 31st October, 2022 at the Cooperative College and ended on the 6th November, 2022.

The objective of the training was to boost productivity and competitiveness of the SMEs to attain growth through learning the fundamental dynamics and principles of, Leather Footwear and Goods, Design, Product Development, Manufacturing, Craftsmanship, Exports Readiness, Transformative Entrepreneurship, Record Keeping, ,and Costing and pricing. This is with the purpose of shifting the mindset to embrace changes and promote replication through knowledge sharing.

Another aspect of this intervention was to enhance SMEs technical capacity and economies of scale to supply both Public and Private Sector institutional buyers by carrying out the assimilation of the Cluster, Incubation center and Design Studio concept in the SMEs Business Strategy, identification of the Public and Private Institutional buyers, identification of the products demanded by the Public and Private Institutional buyers (fashion or non- fashion orientation products, identification of SMEs footwear products for defects against the institutional buyers technical and quality specifications.

The Training was conducted by an external Consultant/ Trainer Mr. Feraw

Kabede from Ethiopia. The ALLPI team comprising

of the Regional Design Studio Manager, Mr Preston Viswamo, and the Institutional Capacity Development and Consultancy Expert – Mr. Michael Kiraye facilitated the training activity.

The training was graced by the Mrs. Yvonne Mpundu, Permanent Secretary, Ministry of Small and Medium Enterprise. In her speech, she explained to the participants the importance and role ALLPI is playing as an organization that is mandated by the Government of Zambia to help develop the leather sector for Zambia. She urged the participants to embrace the training program to ensure that the resources involved to conduct this training are well utilized. She also admonished the participants to gain the knowledge and skills to train others and not keep everything to them, because it is Training of Trainers (ToTs). In addition, she emphasized that the knowledge and skills learned from the training should be put into practice because a lot of training is being offered to SMEs but there is little transformation taking place.

She concluded her speech by appreciating BADEA for providing funding for the equipment and capacity building training, and thanked ALLPI for organizing the training.

The Footwear and leather good Design, Craftsmanship, Export Readiness, Transformative Entrepreneurship, Costing and Record Keeping Training was very much needed and appreciated by the SMEs in Zambia and the government at large.
