### **PRODUCTS**

A (growing) assortment of Products that meets the requirements of:

MSRL = Manufacturing Restricted Substance List ZDHC = Zero Discharge of Hazardous Chemicals

Due to continous efforts this Assortment is growing and added to the range for tanners, which are following this approach. Frequent presentations and invitations to get awareness of this (mostly in Italy today). These conditions are very close to the rigidly defined and controlled conditions of REACH (Registration, Evaluation, Authorization and Restiction of Chemicals)



### PRODUCTION OPTIMIZATION

Optimization of time and raw materials in order to reduce both factors as much as possible. Modulated products that cover the totality of tanning process:

- Beamhouse
  - Tannage
- Re-Tannage
  - Dyeing
  - Finishing



### **PACKING**

Usage of suitable containers made of plastic, metal and paper. Approved ADR packages which guarantees re-usage but NOT re-cycled!

Re-usage of drums and (1.000 L) cubes after cleaning (only in local market). Introduction of RainSafe Paper bags to reduce plastic bag usage. Controlled discharge of used packages. Using packing which is accredited with PEFC and FSC.

PEFC = International Forest certification system. To develop sustainable forestry in relation with production, environment and social interests

FSC = Promotes the management of the world's forests in an appropriate manner for the environment, socially useful and economically sustainable.



### **ENERGY**

Energy consumption, particularly electric, minimized by using latest generation plants with energy saving, such as inverting motors.

Usage of superheated steam by methane burners in combination with heat exchangers in closed circuits. Installation of solar and photovoltaic panels to produce clean energy



### **WORK PROCEDURES**

The Work Procedures (Production, Maintenance, Cleaning) comply with National and International regulations concerning «Worker Safety and Environmental Protection»
