Product development and export readiness program carried out for SMEs in Uganda, Rwanda, Burundi and Tanzania.

Legalization

In most countries, Zambia, Zimbabwe, Kenya Uganda, Ethiopia, Sudan and Malawi, SME Associations have been registered and recognized as legal entities to transact businesses. This has facilitated the perfomance of SMEs in their respective countries.

- The SMES Cluster committee should be empowered to work as a mouth piece in checking the progress of member states.


